ZONING & SALDO

Over the past 2 years Lehighton Borough, Franklin and Mahoning Townships have been working on updating their respective Zoning and SALDO Ordinances. This joint project was made possible by grant funding through DCED's Municipal Assistance Grant Program and the William Penn Foundation. The new ordinances will be in place sometime late May or June 2022.

LIGHT & POWER DEPARTMENT

The Light and Power Department will be replacing a 1978 Westinghouse 7.5 MVA substation class transformer in late February. The project will involve the removal of one of two existing substation transformers that supply electric to the Borough of Lehighton. It will be a four to five week long project that is scheduled to begin on February 21, 2022. This project involves the removal of the transformer oil and the disassembly of the 7.5 MVA transformer after which a new Virginia Transformer 12/16/20 MVA transformer will be set in place and commissioned. The second 1978 Westinghouse 7.5 MVA substation class transformer is scheduled to be replaced in 2023. These units are being replaced due to the increased electrical consumption in the Borough of Lehighton, and the age of the equipment.

The Light and Power Department will also be removing old poles once all of the existing utilities have transferred their facilities to the new poles.

2022 BUDGET

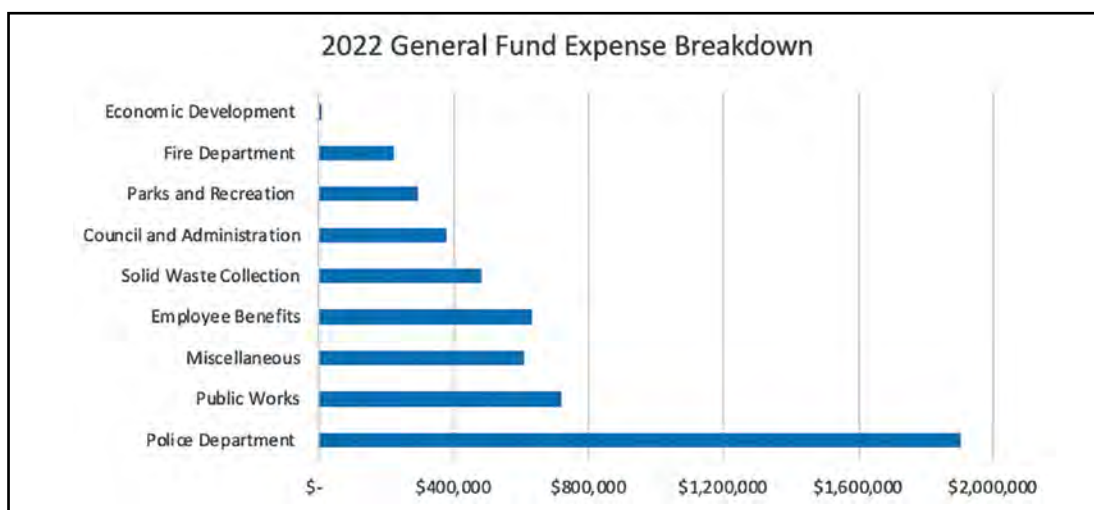
The final 2022 Budget, as adopted on December 20, 2021 sets the real estate taxes at a total of 10 mills with 2 mills allocated to the Fire Station Construction Fund, 1 mill for Fire Equipment and ½ mill for capital reserve for funding capital needs and large projects. The Borough also levies 6 mills for Occupation Taxes.

The 2022 Budget totals \$20,495,939.

GARBAGE & RECYCLING

Changes were made to the **Borough's Garbage/Recycling Ordinance** prior to the start of the new Garbage/Recycling contract. January 2021 the new contract with Tamaqua Transfer began and the changes to the Ordinance went into effect.

The major change is that **only one** garbage toter per household will be emptied per week. This was caused by residents dumping the contents of a property at the curb for garbage pickup instead of renting a dumpster to remove items left behind by the previous occupant. This practice is not fair to the elderly/single residents who put out a small trash bag per week and pay the same garbage rates as those dumping houses at the curb.

One bulk item is still able to be put out per week without a phone call being made to the hauler or the borough. The only **NEW** requirement is that if it is a mattress/box spring or another piece of furniture made with material and padding (couch/chair) it **MUST** be sealed in plastic for the item to be picked up. A "Bulk Item" is an item that will not fit into the trash toter like furniture or an appliance. **It does not mean an extra bag of trash.**



Recycling is still unlimited and residents are encouraged to recycle as much as possible as it will help to lessen the amount of trash going into the toters each week. Please refer to the Tamaqua Transfer Flyer on our website for the list of items that can be put out for recycling.

Street Sweeping on First Street will begin the first Wednesday of March and continue every Wednesday until November 1, 2022. There will be no parking on First Street from 4:00 am – 6:am during this time weather permitting

For street sweeping on all other streets please look for temporary orange “NO PARKING” signs please do not move vehicles back until orange signs have been removed, please do not put piles of debris in gutters for sweeper to pick up.

Please do not blow grass clippings & yard waste into street as this will cause blockage of our storm sewers and could cause ponding on street

NO yard waste should be put in streets

A large black dumpster will be placed behind borough garage for yard waste from April 25 thru May 6 please do not put grass clippings , branches larger than 4” in diameter, or bundles larger than 4’ long in dumpster as the recycling center will not accept them, DO NOT PUT YARD WASTE IN RED DUMSTERS

HYDRANT FLUSHING

Beginning on Tuesday, April 12, 2022 fire hydrants will be flushed in the service area of the Lehigh Valley Water Authority—in Lehigh, Weissport and portions of Mahoning and Franklin Townships. Flushing will be done beginning at 8:00 A.M. and continue until around 3:00 P.M. each day until all hydrants are flushed. Hydrants will not be flushed on Monday's.

Water may be discolored for a short time. This discoloration is not harmful. It is suggested that at this time, you set aside water at night for drinking the next day.

Hydrant flushing is part of our normal operations, in order to keep the system clean for use of our customers.

**Hydrants will be flushed again beginning Tuesday, September 13, 2022.*

HOW CAN I CONTROL STORMWATER ON MY PROPERTY

Have you ever wondered what you can do to help control stormwater on your property? There are many different small projects you may be able to tackle on your own. The following are some ideas:



- **Rain Barrels** – Connect to downspouts to collect and hold water for future use in watering lawns and gardens.
- **Planting Trees** – Planting a tree is a great way to reduce stormwater runoff. Studies have shown that evergreen trees typically absorb more water than deciduous trees, but any tree will help!
- **Planters, Gardens or Landscaped Beds** – If planting a tree isn't an option, adding other types of plants is a great alternative.
- **Pervious Pavers** – If you are thinking about upgrading or replacing your driveway, walkways or patio, consider using pervious pavers that absorb, manage, and reduce stormwater runoff.

INFLOW AND INFILTRATION SMOKE TESTING PROGRAM

Lehigh Borough Council and Lehigh Sewer Authority have been working together to establish an Inflow and Infiltration (I&I) Reduction Program. In 2021, Lehigh Borough Council had approved the development of a smoke testing program to identify problematic areas in the town. The objective of the program is to remove storm water sources from the sanitary sewer system, keep wastewater treatment costs low and to protect the environment.

Smoke Testing is a standard method of detecting sewer defects and storm water cross connections to the sanitary sewer system. Smoke testing involves placing a high-capacity blower on top of a sanitary sewer manhole and forcing “smoke” down into the sewer system. The smoke, under pressure from the blower, travels through the sewer system and escapes through any connection, cracks, leaks, etc. along the way. This method quickly reveals sources of I&I within the study area.

The Public Works Department is in the process of identifying problematic zones in which I&I is a potential issue. Property owners will be notified in advance of the smoke testing study areas and provided with the details of the process.

FAQS

WHAT IS INFLOW? WHAT ARE TYPICAL SOURCES OF INFLOW? Inflow is rainwater or groundwater that enters the sewer system through a direct, piped connection or leaking manhole covers. It is clean water that does not need to be treated as wastewater. Typical sources of inflow include roof downspouts, sump pumps and driveway drains connected to the sewer system.

WHAT IS INFILTRATION? Infiltration is groundwater that enters the sewer system through broken or leaking pipes or leaking sewer manholes. It is clean water that does not need to be treated as wastewater.

HOW IS INFLOW & INFILTRATION IDENTIFIED? Both infiltration and inflow can be estimated by installing flow meters in sewer manholes. Flow meter data is correlated to rainfall and groundwater levels. Inflow is typically identified by conducting smoke testing, dye testing, or building inspections. Infiltration is identified through the inspection of sewer manholes and utilizing a camera to record the condition of the pipes.

WHAT WORK HAS THE BOROUGH COMPLETED TO IDENTIFY I&I? The Borough had conducted a flow meter study in 2018/2019 to identify areas of high flows, identify priority basins for follow up, conduct manhole inspections and developed an electronic map system of drainage areas. Manhole rain dishes were purchased and installed by Public Works. A contractor had been hired to seal the larger manholes in the system and this work will continue. Identifying and mitigating I&I requires long term planning and ongoing studies.

HOW IS I&I REMOVED? Infiltration caused by broken or cracked pipes or manholes can be removed by either rehabilitating the infrastructure. Inflow caused by leaking manhole covers can be removed by replacing the covers. Inflow caused by improper drain or sump pump connections can be removed by re-piping the discharge of the source.

WHY IS IT IMPORTANT TO REMOVE I&I SOURCES? The Borough is required by the Pennsylvania Department of Environmental Protection (PADEP) to identify sources of rainwater runoff and groundwater that enters the sewer system. The Borough pays Central Carbon Municipal Authority for every gallon of water that enters the sewer system regardless of its source. Removal of inflow will reduce sewer capacity, potential overflow issues, protect surface water quality and decrease the overall sewer costs.

HOW DOES SMOKE TESTING WORK? Smoke testing forces smoke-filled air through a sanitary sewer line. The smoke under pressure will fill the main line plus any connections and then follow the path of any leak to the ground surface, quickly revealing the source of the problem. Only enough force to overcome atmospheric pressure is required. As long as openings exist for the smoke to follow, smoke tests are effective, regardless of the surface type, soil type and depth of lines.

WHY SHOULD WE SMOKE TEST? Smoke testing is the most efficient and cost-effective way to locate and identify where clear water is entering the sewer system. Smoke testing is becoming a requirement nationwide for locating clear water problems that are threatening the ability to properly treat wastewater and costing millions of dollars at wastewater treatment plants. Smoke testing will also help identify plumbing leaks in buildings.

WHEN WILL SMOKE TESTING OCCUR? The Public Works Department will notify property owners in advance of the smoke testing dates. Borough Officials will update the website, www.lehightonborough.com and Facebook as scheduling occurs.

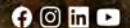

Who Needs Building Codes?

We all do—whether in our homes, offices, schools, stores, factories or places of entertainment. **We rely on the safety of structures that surround us in our everyday life.** The public need for protection from disaster due to fire, structural collapse and general deterioration underscores the need for modern codes and their administration. Most aspects of building construction (electrical wiring, heating, sanitary facilities) can represent a potential hazard to building occupants and users. **Building codes provide safeguards.** Although no code can eliminate all risks, reducing risks to an acceptable level helps.

Who is Leighton Borough's Codes Enforcer?

Barry Isett and Associates, Inc. is the Building Code Official, Zoning and Code Enforcement Officer for Leighton Borough, appointed in 2013. As certified Inspectors, our responsibility is the protection of the health, safety and welfare of the public by creating safe buildings and communities. This is accomplished through the enforcement of federal, state and local ordinances adopted by the Borough.

We take pride in providing a professional level of assistance to the community. Enforcement often begins with a written letter (Notice of Violation) to identify items that are out of compliance, the code requirement, a timeframe for completion and a fine if no action is taken to abate the issues. These items are required to be listed in the notice and may seem overwhelming and are often interpreted as demanding and offering no help. In fact, that is not the case. The Borough wants compliance with codes to ensure health and safety for the community. Isett will work with you throughout the process and provide guidance. Cooperation on your part is needed in order to achieve a successful completion of the project.

Property Maintenance and Quality of Life

One of the Borough's highest priorities is to work with property owners and tenants to preserve and maintain the neighborhoods and commercial areas. The presence of property nuisances detracts from the enjoyment and quality of life in the community. Isett handles complaints related to private property nuisances, both residential and commercial. You can assist Code Enforcement by reporting any condition you believe to be a nuisance.

Together, we can keep Leighton Borough a beautiful place in which to live and do business.
